


EDTC - 3 Medications Administered in ED






EDTC - 3 Medications Administered in ED






OP AMI/CP Rate Based Measures - 2Q21




OP AMI/CP Continuous Measures - 2Q21









OP1 - Median Time to Fibrinolysis




OP2 - Fibrinolytic Therapy Received Within 30 Minutes




OP3a - Median Time to Transfer to Another Facility for Acute Coronary Intervention - Overall




OP3b - Median Time to Transfer to Another Facility for Acute Coronary Intervention - Reporting Measure




OP3c - Median Time to Transfer to Another Facility for Acute Coronary Intervention - QI Measure




OP4a - Aspirin at Arrival - Overall Rate




OP4b - Aspirin at Arrival - AMI



OP4c - Aspirin at Arrival - Chest Pain




OP5a - Median Time to ECG - Overall Rate






OP5c - Median Time to ECG - Chest Pain




OP18a - Median Time from ED Arrival to ED Departure for Discharged ED Patients - Overall






OP18c - Median Time from ED Arrival to ED Departure for Discharged ED Patients - Psychiatric/Mental Health Patients




OP18d - Median Time from ED Arrival to ED Departure for Discharged ED Patients - Transfer Patients




OP20 - Door to Diagnostic Evaluation by a Qualified Medical Professional




ED-1a - Median Time from ED Arrival to ED Departure for Admitted ED Patients - Overall Rate






ED-1b - Median Time from ED Arrival to ED Departure for Admitted ED Patients - Reporting Measure




ED-2a - Admit Decision Time to ED Departure Time for Admitted Patients - Overall Rate









OP-1: Median Time to Fibrinolysis




OP-2: Fibrinolytic Therapy Received Within 30 Minutes




OP-3a: Median Time to Transfer to Another Facility for Acute Coronary Intervention - Overall




OP-3b: Median Time to Transfer to Another Facility for Acute Coronary Intervention - Reporting Measure










OP-4c: Aspirin at Arrival - Chest Pain




OP-5a: Median Time to ECG - Overall Rate


















ED-1a: Median Time from ED Arrival to ED Departure for Admitted ED Patients - Overall Rate






