

#### What are Medals of Achievement?


- Organizations incorporating Person and Family Engagement (PFE) and/or Health Equity to drive improvement during the 2022-2024 Governor's Award of Excellence program will also be eligible to earn up to two Medals of Achievement in any of their chosen award categories.
- Organizations may earn one or both Medals of Achievement in each chosen award category (up to three measures selected during self-nomination) for a maximum of three Governor's Awards of Excellence and six Medals of Achievement.
- Medals of Achievement are optional.







#### **Organization A:**




- The maximum number of Medals of Achievement that an organization can earn is **six**.
- In this example, Organization A is choosing to work toward four of the maximum six Medals of Achievement they could earn.



#### **Organization B:**

#### Award 1: Infections: C. Difficile Rate Measure



- The minimum number of Medals of Achievement that an organization can earn is one (or none if you choose not to work toward any because Medals of Achievement are optional).
- In this example, Organization B is choosing to work toward one of the maximum two Medals of Achievement they could earn.



### What to Expect

- After the implementation period ends (May 31, 2024), you will receive final reports and be able to identify if you earned a Governor's Award of Excellence.
- We will send a survey that resembles the Medals of Achievement checklist.
- If you completed a PFE or HE project that contributed to your progress toward a measure, you will inform our team using the survey.
