What is the National Health Service Corps?

The National Health Service Corps (NHSC) is a federal program established to improve access to healthcare in underserved areas across the United States.

Mission: The NHSC aims to build healthy communities by supporting qualified healthcare providers dedicated to working in areas with limited access to care, known as Health Professional Shortage Areas (HPSAs).

Purpose: By offering financial incentives, NHSC helps address the shortage of healthcare professionals in rural, urban, and tribal communities that face significant health disparities.



NHSC Programs and Impact

- NHSC Loan Repayment Program: Provides loan repayment assistance to licensed healthcare providers who serve at NHSC-approved sites in HPSA.
- NHSC Scholarship Program: Offers scholarships to students pursuing primary care health professions in exchange for a service commitment in an underserved area after graduation.
- NHSC Substance Use Disorder (SUD) Workforce Loan Repayment Program:
 Targets healthcare providers who treat individuals with substance use disorders in areas particularly affected by the opioid crisis.
- NHSC Rural Community Loan Repayment Program: Focuses on improving healthcare in rural communities by supporting providers who work in rural HPSA.



NHSC Scholarship Overview

- The NHSC Scholarship Program offers financial support to students pursuing eligible primary care professions. Scholarship recipients commit to serving in a Health Professional Shortage Area (HPSA) upon graduation. Key benefits include:
 - Tuition and Fees: Covers the full cost of tuition, fees, and eligible educational expenses
 - Monthly Stipend: Provides a monthly living stipend while in school
 - Service Commitment: Requires a commitment to work in an NHSCapproved site in a designated HPSA



Why become a National Health Service Corps approved site?

- NHSC-approved sites can use their status to recruit and retain healthcare professionals through the NHSC network of care providers.
- Utilize the Health Workforce Connector site to reach clinicians seeking work in communities with limited access to care as well as participate in virtual job fairs
- NHSC scholars are provided travel allowance and supportive services for pre-employment travel as well as relocation expenses

Application Process

- The new site application cycle is for sites that:
 - Have never been NHSC-approved, including sites that have applied and had their application denied or canceled
 - Are currently inactive for NHSC due to expiration or past compliance issues
 - Application cycle expected to open in Spring 2025
