

Rural Health Rising Podcast - Ep. 83: Telehealth and NRHA Update



Telehealth was brought to the forefront of healthcare delivery models during the COVID-19 pandemic as patients were hesitant to leave their homes and the need for isolation and social distancing required more virtual care.

During the public health emergency, telehealth has been reimbursed, but the future of that reimbursement is uncertain as the expected end of the public health emergency looms.

So, how do rural hospitals understand and advocate for reimbursement to sustain telehealth as a standard care delivery option. a general overview of EMTALA requirements and information on how to file a complaint against a provider/supplier if an individual feels EMTALA has been violated.

EMTALA guarantees access to emergency medical services regardless of an individual's ability to pay and protects against unnecessary patient transfer to another facility. This includes rights regarding:

- Screening
- Stabilizing treatment
- Delay in examination or treatment
- Appropriate transfer

Anyone can file an EMTALA complaint with the **State Survey Agency**. The State Survey Agency will investigate the issue and, when appropriate, verify corrective action is taken to ensure the hospital is no longer in violation of EMTALA.

# Announcing Maternal and Infant Health Grant Funding Request for Proposals

The Michigan Health Endowment Fund seeks proposals for community-driven, locally focused projects that improve health for mothers and infants in Michigan communities. Projects must incorporate at least one of three priority categories:

- Address service delivery environment barriers to improving access to equitable healthcare
- Increase access to protective and clinical interventions
- Address targeted policies, practices, and procedures at the local or practice level that impact or prohibit the best outcomes for mothers and infants

Concept papers, which are highly recommended, are due January 10. Full proposals are due February 21.

# Community Paramedicine Enhances Value and Savings -Huron Valley Ambulance Case Study

There is growing evidence that CP programs produce significant savings for the healthcare system and provide more convenient patient care.

CP programs:

1. Reduce unnecessary emergency department use by addressing lower-acuity needs in community-based settings 2. Reduce costly hospital readmissions by providing follow-up services—like blood draws, wound and foley care, assessments, IV fluid administration, and a number of bedside lab services—in post-acute care settings 3. Improve the convenience of care for patients by treating patients at home or in their nursing care facilities, rather than requiring them to obtain transportation to appointments

Evidence suggests that treating patients in place through CP programs has many positive outcomes and benefits. But in the absence of universal reimbursement for CP services, these programs must work hard to maintain services. We demonstrate this through a case study of Huron Valley Ambulance Community Paramedicine, one of Michigan's first and most innovative CP programs.

This brief should be of interest to providers, payors, and policymakers that wish to better serve vulnerable and at-risk patients in community-based settings while realizing health care cost savings.
