

In 2011, FORHP, located within HRSA, created a program to promote high quality of care at rural hospitals with 25 beds or fewer. Low-volume hospitals participating in the Medicare Beneficiary Quality Improvement Project (MBQIP) voluntarily report on a set of quality measures relevant to the care they provide, share data, and take on quality improvement initiatives.

Peters Announces Bipartisan Legislation Expanding Veteran Burial Benefits

Legislation Named After Late Michigan Veteran Gerald "Jerry" Elliott

As part of the efforts of the new *Improving Rural Enrollment, Access, and Health in Rural Veterans* (I-REACH) program, it is important to share information that will assist Michigan's Veterans in rural communities gain access to healthcare and resources.

U.S. Senator Gary Peters (MI) announced bipartisan legislation – the Gerald's Law Act – that would expand Department of Veterans Affairs (VA) burial benefits eligibility to terminally ill veterans who pass away at a non-VA facility while receiving hospice care. The legislation was named after late Michigan veteran Gerald "Jerry" Elliott of Kingsford who did not receive VA burial benefits since he passed away at home.

Under current law, the VA will cover nearly \$800 toward burial and funeral expenses only if the veteran is hospitalized at the VA at the time of death. This legislation would update the department's policy, ensuring veterans aren't penalized for spending their last days in the comfort of their homes or other settings. Denise Formolo, the Veterans Service Officer for Dickinson County, raised this issue with Senator Peters' office and shared the heartbreaking story of the Elliott family – inspiring this legislation.

The modules in the toolkit contain resources and information focused on developing, implementing, evaluating, and sustaining rural health literacy programs.



The Michigan State Housing Development Authority Wants to Hear From You!

Housing pressures continue to intensify across the state, most recently seen in Alpena as several families have set up tents in the Alpena County Fairgrounds due to being priced out of the local rental market. Like many across the state, this region has continued to see a rise in housing prices, while the available housing is not nearly enough to meet the demand. The State of Michigan has recently received \$100 million in federal rescue funds for housing to help ease shortages. These funds are part of the \$3.1 billion awarded to the state through the federal American Rescue Plan Act. These funds have been divided into two programs of \$50 million each, managed by the Michigan State Housing Development Authority (MSHDA). MSHDA is looking for your feedback on how to spend these funds appropriately.
