Apply Today to Participate in MCRH's New Community Based Palliative Care Project

Apply by February 16, 2025



Rural Community teams must be multi-site and interdisciplinary, possible representatives from hospitals, clinics, home health agencies, nursing homes, hospice programs, and tribal health organizations.

The Michigan Center for Rural Health, in partnership with Stratis Health—a leader in community-based palliative care programs—encourages your community to apply for the Cultivating Comfort: Enhancing Palliative Care in Rural Michigan Project. This two-year learning and planning initiative is designed to help communities establish or strengthen palliative care services. The project will begin in January 2025 and continue through December 2026.

To be eligible for the project, rural community teams must be multi-site and interdisciplinary, possible representatives from hospitals, clinics, home health agencies, nursing homes, hospice programs, and tribal health organizations. Up to five rural communities from around Michigan will be selected to participate in this program, which is funded by the Michigan Health Endowment Fund.

A community must designate one organization to apply on behalf of the community team. Community teams will reflect the unique needs of their communities and must be multisite and interdisciplinary. Teams may include representatives from hospitals, clinics, home health agencies, nursing homes, hospice programs, community-based organizations, and other key stakeholders. The application should include a clear commitment from all key health care providers and organizations working together to support your community.

While there is no fee to participate in the collaborative, participating organizations must commit resources and staff to the initiative.

Community selections will be announced on March 14, 2025.

Exciting Mini-Grant Opportunities for Improving Health in Rural Communities



The American Heart Association is proud to announce two mini-grant programs designed to foster healthier lives in the rural Midwest. These grants are tailored to address pressing health challenges, from managing chronic diseases to tackling social drivers of health in innovative and sustainable ways.

The Blood Pressure & Beyond Mini-Grant offers up to \$2,000 to healthcare organizations for implementing evidence-based policies and practices that enhance chronic disease management. Applicants can use the funding to adopt new blood pressure measurement practices, develop collaborations addressing social drivers of health, or create innovative workflows connecting patients to community resources like nutrition assistance or blood pressure self-monitoring.

The Meeting People Where They Are Mini-Grant provides up to \$1,500 for community-based organizations committed to improving health in trusted local spaces, such as libraries, food pantries, and community centers. Projects may include empowering residents to monitor their own blood pressure, enhancing access to nutritious food, or improving cardiac emergency response planning.

Access to Training for Behavioral Health Providers



To help improve access to training for behavioral health providers, the Michigan Department of Health and Human Services (MDHHS) has awarded a contract to Public Consulting Group (PCG) following a competitive bid process to develop and implement a Capacity Building Center (CBC).

The CBC will offer select children's behavioral health training for public mental and behavioral health providers contracted through Community Mental Health Service Programs and Prepaid Inpatient Health Plans. It will provide a centralized resource for providers to access training opportunities to continue to grow the capacity and knowledge of those supporting children, youth, and their families.


Initial trainings expected to be coordinated through the CBC include the following topics:

- Michigan's Child & Adolescent Needs and Strengths assessment tool.
- Intensive Care Coordination with Wraparound.
- Children's Waiver Program and Serious Emotional Disturbance Waiver.
- Other Medicaid-funded specialty behavioral health services for children, youth, and families.

MDHHS will continue to work with PCG to add additional training opportunities once the initial implementation and evaluation of the CBC is complete. The CBC website is slated to launch in May 2025.

Primary Care Collaborative 2024 Evidence Report: An Evaluation of Primary Care in Medicare Accountable Care Organizations



Last spring, the Congressional Budget Office (CBO) released an issue brief highlighting the more significant savings achieved by Medicare Accountable Care Organizations (ACOs) that are led by independent physician groups and those with a high proportion of primary care physicians. This report was welcome news about the success of a value-based payment model—the Medicare Shared Savings Program (MSSP)—from the official budget scorekeeper for the U.S. Congress.

The Primary Care Collaborative (PCC)'s 2024 Evidence Report examines primary care centric ACOs, defined as those with a high proportion of participating primary care physicians and evaluation and management visits by primary care. Using quantitative and qualitative analyses, the reporting seeks to better understand what contributes to their success and inform policymakers and innovators working to move our healthcare system from volume to value.

PCC partnered with the Robert Graham Center and Simple Healthcare to produce this report.

2025 Physician Fee Schedule Webinar – January 30




The Centers for Medicare and Medicaid Services (CMS) recently updated the Physician Fee Schedule (PFS) for 2025 through the Calendar Year 2025 PFS Final Rule. A free webinar will take place on January 30 at 2 PM EST to guide participants through the updates.

Rural Health Clinic CY 2025 All-Inclusive Rate



CMS updated the rural health clinic (RHC) all-inclusive rate for CY 2025. The payment limit per visit for independent and provider-based RHCs in hospitals with 50 or more beds is \$152.00.

The payment limit per visit for specified provider-based RHCs with an April 1, 2021, established payment limit that continues to meet the qualifications in section 1833(f)(3)(B) of the Social Security Act is the greater of these amounts:

- 1. Your payment limit per visit starting January 1, 2024, increased by 3.5%
- 2. The national statutory CY 2025 payment limit per visit of \$152.00

Medicare Advantage Enrollment Update 2024



This policy brief continues the RUPRI Center's annual Medicare Advantage (MA) enrollment updates. In addition to tracking overall and nonmetropolitan/metropolitan (rural/urban) MA enrollment, this brief also reports on changes in enrollment in types of MA plans. The Center's ongoing line of inquiry also considers policy changes from previous years that may have impacted MA plan enrollment.

Key Findings

- Medicare Advantage (MA) enrollment now exceeds 50 percent of eligible beneficiaries (enrolled in both Part A and Part B) in metropolitan counties (56.1 percent); at the current rate of growth, nonmetropolitan enrollment is expected to exceed 50 percent (currently 48.1 percent) next year, in 2025.
- While the annual rate of MA growth continues to exceed the growth rate in total Medicare eligible beneficiaries, it has moderated somewhat from previous years.
- Much of the growth in nonmetropolitan MA enrollment has been in plans using local preferred provider organizations (PPOs), accounting for most MA enrollees in nonmetropolitan counties since 2022.

Medicaid Behavioral Health Providers & Telehealth Service Usage Pre and During COVID-19



This study examines the extent to which Medicaid providers who deliver behavioral health services shifted their practices to mostly tele-behavioral health services during the COVID-19 pandemic.

During the COVID-19 pandemic, providers of mental health or substance use services (behavioral health services) quickly transitioned to telehealth due to social distancing recommendations. Telehealth helps overcome long-standing barriers to accessing behavioral health care, such as limited provider availability and lack of transportation in some communities. Tele-behavioral health services can enhance patient outcomes, reduce care costs and time, and offer confidential options for those hesitant about inperson services.

Shifting behavioral health services from in-person to telehealth could, however, have unintended consequences. Certain populations, including people with disabilities or those with limited Internet access or comfort with technology, may find it difficult to engage in telehealth, and it can limit the ability of providers and patients to develop therapeutic relationships.

This study found that the proportion of providers who delivered more than 80% of their behavioral health services via telehealth increased during the pandemic, with one-quarter of specialty providers delivering most behavioral health services via telehealth.
