House Passes Bipartisan Telehealth Policy Extension for Two Years

Recently, The House overwhelmingly passed [H.R. 4040](#), Advancing Telehealth Beyond COVID-19 Act of 2021.

This legislation would extend a variety of Medicare telehealth flexibilities, currently set to expire on the 152nd day after the end of the Public Health Emergency (PHE), to now continue through December 31, 2024.

Michigan Proposing Updates to Medicaid Telehealth Policy

According to our partners at Health Services Associates, current policies are still in effect until the COVID PHE ends.

The current termination date is 10/15/2022, however, a 60 day notice will be communicated before the end so it will likely be extended again.

Summary of proposed changes:

1. Video/audio will still be covered for all services (not just mental health as Medicare is planning), see links in the bulletin for specific CPT code lists
2. Telehealth modifier will change from GT to 95
3. POS will be where the service was/provider located which would be 72 for the office, but due to the UB 04 format there really is no POS
4. AUDIO only is NOT covered, you'd bill the audio only codes (99441-99443 and 98966-98968) but they will not generate a payment, no T1015 would go with these codes, so no payment.

MDHHS Announces Free COVID-19 Tests Through Rockefeller Foundation Partnership

The Michigan Department of Health and Human Services (MDHHS) is announcing its expanded partnership with the Rockefeller Foundation through Project Act to provide 180,000 COVID-19 tests to 36,000 households located anywhere in the state free of charge. Previously, tests were only available in select ZIP codes.



Residents can request the tests through the end of August. Households will receive one kit containing five tests.

“Testing remains both a critical and helpful tool in managing the spread of COVID-19, and reduces the risk of getting infected for our loved ones and neighbors,” said Dr. Natasha Bagdasarian, MDHHS chief medical executive. “We encourage residents to take advantage of these free tests as many families get ready to head back to school. We are grateful for our partnership with the Rockefeller Foundation to ensure equitable access to tools that prevent COVID-19.”

All households in the state of Michigan can order their free COVID-19 tests through [AccessCovidTests.org](https://www.access-covid-tests.org). Each household will receive one kit with five tests, typically within a week of ordering. Individuals without internet access can contact 211 for assistance ordering tests.

This program is in addition to free at-home tests available through the federal [government partnership with the United States Postal Service](#).

MDHHS continues to partner with libraries across the state to provide free at-home COVID-19 tests to Michiganders. [Click here](#) for a list of participating libraries.

Private health insurers are [required to cover](#) up to eight at-home COVID-19 tests per month for each person covered by a health plan.
